University of Wisconsin Hosts Annual VE Workshop August 4-8

THE FIFTH ANNUAL WORKSHOP in value engineering will be conducted August 4-8 at the Wisconsin Center, University of Wisconsin, Madison.

The workshop, which is sponsored by SAVE, is designed to provide participants with the theory and practical knowledge of value analysis and value engineering. There will be a special emphasis on the commercial application of value engineering techniques.

Enrollment fee is \$250 for nonmembers of SAVE; \$225 for members. The nonmember fee includes a year's membership in the Society plus all session materials, manual, and luncheon.

Workshop Coordinator is Professor Fred Schwarz, representative for value programs at the Management Institute of the University of Wisconsin, and former Vice President of SAVE.

Faculty for the workshop includes R. L. Crouse, Manager of

Value and Industrial Engineering, Honeywell, Inc., Minneapolis, Minn., and SAVE National President; and C. W. (Smokey) Doyle, Corporate Director of Value Control, General Dynamics, Ft. Worth, and Past President of SAVE. Guest speaker will be Edwin V. McGuire, Manager of Value Engineering, Ford Motor Company, Detroit.

According to Coordinator Schwarz, the workshop will apply value engineering tools and techniques to current products provided by the participating companies. Each participant (or company team) will be invited to provide a product or service with supporting data. The teams will apply the value approach to these products or services during the workshop.

Each participant will also be provided with an instructor's manual and material to conduct a similar program in his own company.

Most SAVE members should have enrollment forms by now.

COMMUNICATION FROM YOUR PRESIDENT

Your administration, which took office at the annual conference in San Diego in April, will report to you on an interim basis in the "Communications" and the "Journal" on program activities with which you charged us. At the end of the year we will present to the annual business meeting a status report of the achievements versus goals and objectives for the total national organization.

You have personal and individual responsibilities as well as assigning some to your elected administration. One of your responsibilities is to pay dues. It could be that some of you feel that that is your only responsibility in this Society. I hope that an accusation of this kind, relegating you to spectator status, raises the hackles of every member in this Society.

Beyond dues it is your responsibility to elect local, grass-root chapter officers each year. If we are to communicate between chapters and between the National organization and the chapters, it is necessary that we have an up-to-date listing of all local elected officers in the National Business Office. Will you see that this listing of officers is transmitted, at once, to the National Business Office, making sure that their proper addresses are listed against the individual people?

You, the members, are the Society. It is your responsibility to each other and to yourselves to see that there are programs and chapter activities that will help you and other members both in the techniques and methodology of value engineering and in the application of these techniques and methodology in the organizations where you earn your living. New, different, and successful applications of value engineering should be written up and relayed to Bill Dean, Vice President for Communications. Bill will relay this information to all chapters, and hopefully to the individual members to avoid wasted efforts like re-inventing the wheel.

You have a further responsibility to see that value engineering is successfully applied to a greater extent than ever before. It is your responsibility, during the quiet summer when most chapters are in a state of suspended animation, to write and lay the ground work to have written, papers for presentation at the Dallas/Fort Worth Conference, in April, 1970. I challenge you members TO OVERWHELM THE PAPERS COMMITTEE for the Fort Worth/ Dallas conference.

Our efforts are to increase the implementation of value engineering results into devices, systems, procedures and processes. We must have line people help us by explaining, telling, extolling, urging and demanding "how" value engineering people should present recommendations that can be used in their areas of responsibility. This challenge is to get line operating people in your organization to prepare such a paper for presentation at the National Conference. Their opinions of how and what value engineering programs should produce to best help them and to best gain their acceptance with implementation of changes is what we need desperately to know. The line people need acceptably recommended changes for cost improvement in the terrific competitive and profit battles they face.

I have made a list of ten line operating people, by name, in my organization that I will approach within the next weeks, asking them to prepare such a paper and presentation. These people are in the areas of design, procurement, production operations, production engineering, and manufacturing (machine shop). I suggest that you make a similar list in your operations and follow through with this request. Try a "marketeer" first; he might thoroughly enjoy telling the value engineering clan what help he wants from us to make his efforts more successful.

- Jim Bomberger, National Director, Constitution and Bylaws. submitted a series of recommended modifications to the Constitution. Most of the changes are minor in nature, but five of them will be submitted by ballot to the voting membership.
- Bill Dean. Vice President for Communications recommended that the Society not enter into an agreement to publish the SAVE JOURNAL with Pergammon Press.

Five Constitutional Amendments To be Submitted to Membership

FIVE PROPOSED AMENDMENTS TO THE Constitution of the Society will be submitted soon to the voting membership for ratification. Briefly, these amendments would cover:

• Article IV Membership, Constitution Section 17—Generally intended to protect the rights of the individual members (and is presently granted in the existing Bylaws, Article III, Section 5).

• Article VII Board of Directors, Constitution Section 5—Proposed to assure representation of the membership. This will require eight of the current fourteen Board members to be present in order to conduct Society business.

• Article IX Officers, Constitution Section 1—This proposal deletes the "/Secretary" from the title of the Executive Vice President and changes the title of "Treasurer" to Vice President for Finance. These changes are proposed to make the titles of national officers harmonious with those of other technical societies.

• Article XII Nominations and Elections, Constitution Section 6-77 Proposal to hold the annual election thirty days earlier in order to effect a smoother transition between incoming and outgoing officers.

• Article XVI Constitutional Amendments, Constitution Section 3—The existing provisions for mail
