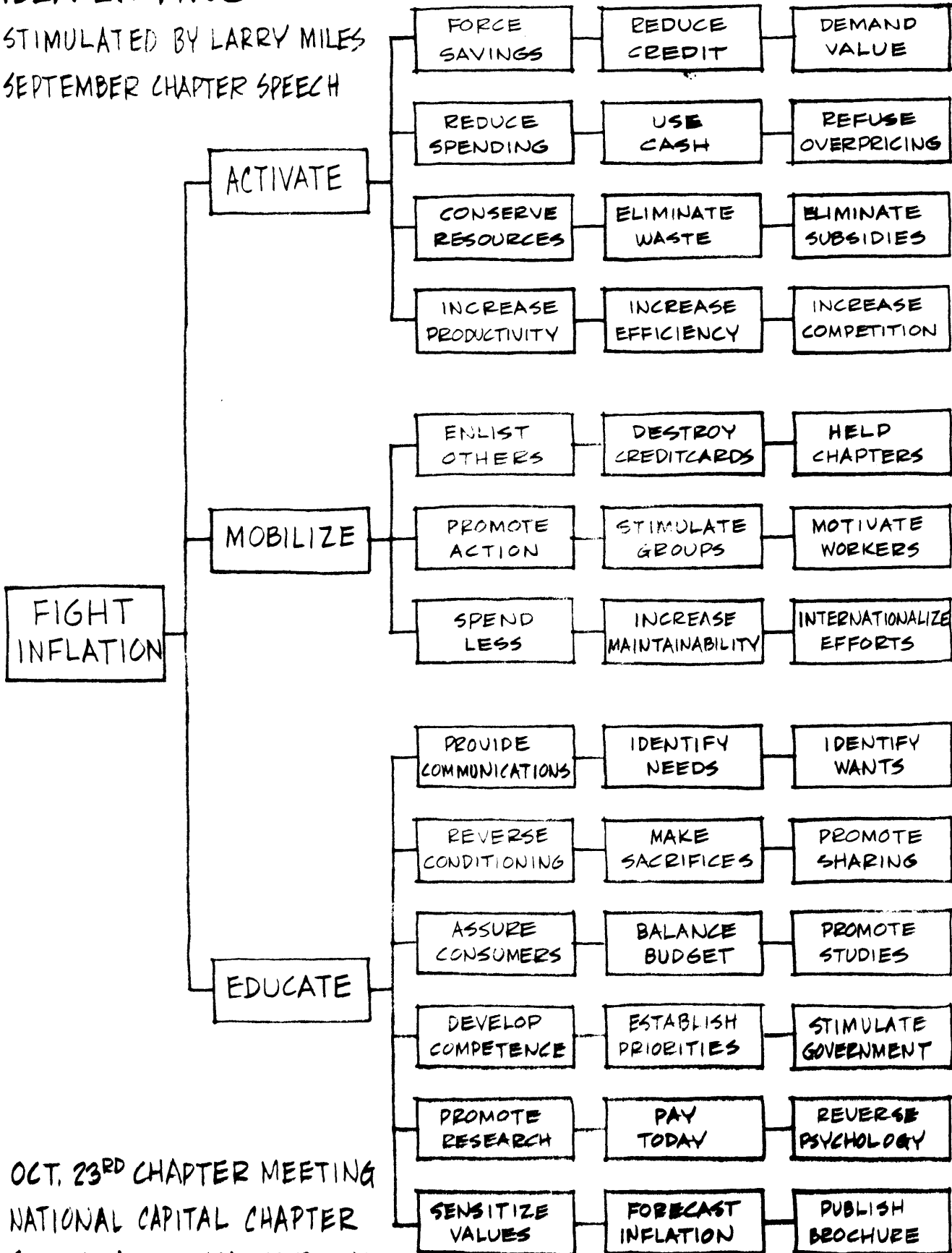
TRACKS ON THE OCTOBER BRAINSTORMING SESSION
